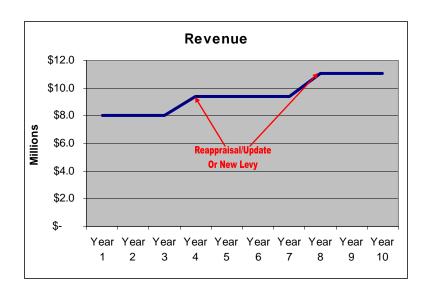

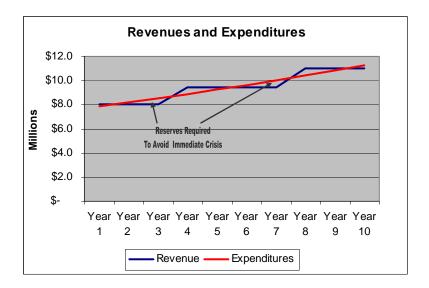

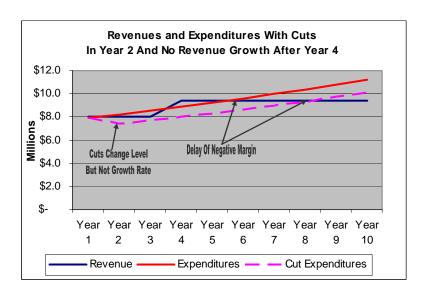
The "Dick Maxwell" Presentation On Ohio School Finance:

Under Ohio's school funding scheme, revenues remain relatively flat until something increases them, such as a new levy, reappraisal, influx of students, or new source of funding is derived (e.g. open enrollment). In 2006, Madison revenues grew to a new plateau by virtue of the \$1.1 million emergency levy and the institution of open enrollment. Since we are on a guarantee due to declining local resident enrollment, our state funding remains the same from year to year under current law. Our main source of new "steps" to our revenue graph is the triennial reappraisal/update process.

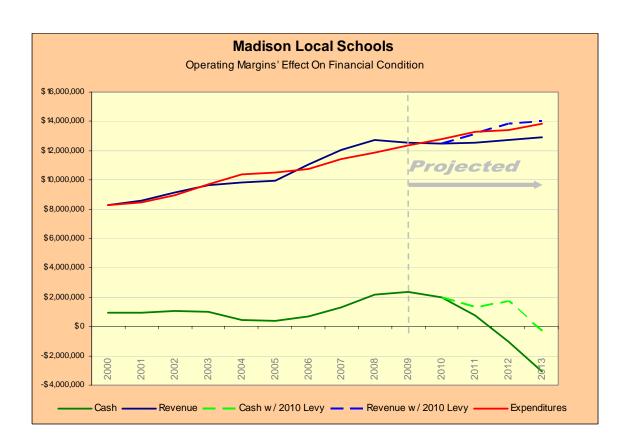




Expenditures tend to grow at a constant slope, only diminishing significantly when there is a major change in policy. This is because of funding mandates and inflation rates that are largely beyond the control of the board. Even when cuts lower expenditures, the rate of growth from that new level is very similar to the rate that existed prior to the cuts. Frugality and efficiency can affect the rate of growth to a moderate level, but generally not to significantly extend the term of a positive operating margin. Because of the growth of expenditures being largely beyond the control of the board, cuts after efficiency has been obtained will only delay the onset of financial crisis in the absence of adequate growth of revenues, not totally alleviate it from the future. Repetitive cuts will diminish programs but not bring a permanent answer to the funding gap. This exemplifies why "you can't cut your way to prosperity."



Due to cuts in previous years and new ways of doing business, Madison has built reserves that will extend the sufficiency of our current revenues, but not indefinitely. The current projection is for the district to achieve a negative operating margin in FY 2010 (excluding unprojected OE funds). Abnormally low valuation reappraisal/update rates because of the housing market crisis could cause the financial picture to deteriorate. One bright picture is the additional open enrollment revenue currently being received. By not projecting more than 40 OE students until the October count, and by not expanding student capacity (only filling empty seats), the board is receiving additional reserves from the additional OE students that will extend the sufficiency of its revenue streams.



The major assumption change for the five year forecast since the May 2008 version centers around purchased services. Higher inflation is now projected for these costs, as exemplified in the 2008-09 district budget. The following chart shows the spending that contributes to this area of cost and the rate the budget has grown since 2007-08.

SUMMARY

The maintenance of a stable financial situation at Madison Schools depends on certain variables that are tied to key assumptions. Principally, the timely renewal of the district's \$1.1 million emergency levy in 2010 looms large. In addition, while the stability of open enrollment at a low level (40 FTE) is assumed, maintenance of the current open enrollment (96 FTE) could affect the forecast by extending positive year-end general fund balances into the future

Another salient assumption revolves around the economy, not only insofar as inflation affects expenditures such as fuel and health insurance, but also its impact on the 2011 triennial valuation update. Recovery of the housing market by 2011 could improve the forecast, but conversely, if the market deteriorates to produce no growth in residential values, a critical revenue shortfall may result. The next state biennial budget may also cause important new economy-driven considerations for future forecasts. Any revision to the funding model that erodes or eliminates the transitional aid guarantee without some offsetting revision to the formula aid calculation will undoubtedly have a negative impact on Madison.

As it stands, Madison is in a guardedly optimistic position for a district on a state funding guarantee and in an area experiencing slow economic growth. Cuts over the past few years have stretched the sufficiency of the 2005 emergency levy without affecting program quality. Cash reserves have been bolstered by the cuts and open enrollment, helping to offset projected operating deficits beginning in 2010.
