# **Special Presentations:**

Washington, D.C. trip – Tammy Andrews and 8<sup>th</sup> grade students: Presented slides, thanked the Board, chaperones, and faculty for their support.

Career Education – Carolyn Smith: Explained her role, the Butler Tech website and the importance of career-technical training. Students can be assessed, guided, and even take coursework through the Butler Tech website. Students lack knowledge about opportunities, and this program helps them realistically develop career plans and skills to go along with their dreams. Students don't always connect their education with choosing a career.

**Construction Update -** Kim Plummer and Vic Keykens: The project is 15% complete, footers are finished, underslabbing and walls are progressing.

Tom York: Change order for south parking lot is coming due to conditions. The south field is progressing – alternate practice field being planned. There is a new roof on the Intermediate Building gym.

The final amended appropriations will be reflected in the July Treasurer's Report.

- E. Adopt FY10 Appropriations as presented by the Treasurer, to be amended subject to year-end balances, and reported in final form at the next regular meeting.
- F. Treasurer's Report: Auditor of the State Committee Various topics on accounting and compliance are being studied to provide uniform guidance to treasurers. Among these are retirement system service credit, ethics, IRS issues, performance audits, and student activity procedures. Unlike with banking bailouts, schools will be held to a high level of accountability for federal stimulus dollars.

Chart of Accounts (account codes) revisions for federal stimulus categorical programs have been instituted, separating FY10 and Fy11 funding. The portion of the stimulus subsidizing the state foundation will also be broken out, which is unique for unrestricted funds. It is estimated that about 16% or \$976K of our foundation will need to be tracked separately. One implication is that districts need to make sure that they are planning for the loss of these funds in the next biennial state budget. Superintendent and Treasurer will be segregating costs accordingly to satisfy this new requirement.

Bleacher lease is paid in full, freeing up \$38,800 in the 2010 permanent improvement budget.

Butler County treasurers met and discussed the new cooperative Medicaid billing service to be offered by the Butler County Educational Service Center. As with any program, there are pitfalls to be avoided.
