- Interior metal and framing 92% complete
- Roofing 95% complete
- Change order Presentation for Feldkamp Enterprises in the amount of \$38,032 due to design error, improper scale on bid documents. Removed all overhead and profit in negotiations with the company (40% materials/labor). Bid increase of \$40,000 would not have impacted the contract award.

Treasurer's Items

CFO Notes:

- Income tax receipts are down 10.7% from last FY, with one more distribution in April.
- Down \$139.5 million for the month from the previous estimates at the State level, Ohio income tax receipts are down 3% from estimate for the year. Overall, Ohio income tax receipts have dropped 13.7% from last year. There is one remaining distribution for FY10.
- Preliminary EMIS reports for October indicate we will have about a 26 net student increase in open enrollment (in and out), while we lost about 35 additional resident students over last year. Community school losses show an increase of 12 FTE.

- 1. First reading of addition to Bylaws and Policies Manual: USE OF RESTRAINTS. The policy is motivated by a new law in the Special Education area (Charles Miller bill).
- 2. Angie Whiteman asked for and received an explanation of competitive procurement practices for facilities projects. Mr. Dulle provided an explanation and examples. Some work is best performed by a single source for consistency.

Board of Education Reports/Communications:

Butler Tech. Report – Mr. Miller: Dr. Sommers is leaving, and the Board is getting community and faculty forums organized to provide input for a national superintendent search.

Legislative Report – Mr. French discussed various bills with possible impacts to schools:

- HB 330 allows schools to enter into contracts with ODOT for purchasing of materials such as road salt.
- HB 316 amends existing laws to promote HIV and AIDS prevention in schools.
- HB 167 addresses performance ratings for school districts and buildings (Mr. French has the entire bill for anyone interested.
- Madison's policies must be reviewed for compliance to HB19, which addressed harassment and bullying.
- State sales tax receipts are up \$10m for January or 1.5% above estimates, up \$22m for the year.

- Junior Aly Malott has scored over 1,000 points in her high school varsity basketball career
- Boys basketball vs. Dayton Christian collected money for cancer after the game.
